## 1. PRECAUTIONARY MEASURES AGAINST THE CORONAVIRUS DISEASE ("COVID-19")

In line with the Government's directive and the revised Guidance Note and Frequently Asked Questions ("FAQs") on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia on 16 July 2021 ("SC Guidance Note"), the 21<sup>st</sup> AGM of the Company will be conducted **on a fully virtual basis through live streaming from the Broadcast Venue.** 

The Broadcast Venue of the 21<sup>st</sup> AGM is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016, whereby the main venue of the meeting shall be in Malaysia and the Chairman of the meeting shall be present at the main venue of the meeting. Shareholders/proxy(ies) from the public **WILL NOT BE ALLOWED** to attend the 21<sup>st</sup> AGM in person at the Broadcast Venue on the day of the meeting.

Due to the constant evolving COVID-19 situation in Malaysia, we may be required to change the arrangements of our 21<sup>st</sup> AGM at short notice. Kindly check the Company's website or announcements for the latest updates on the status of the 21<sup>st</sup> AGM.

The Company will continue to observe the requirements and guidelines issued by the Government of Malaysia, Ministry of Health, Malaysian National Security Council, Securities Commission of Malaysia and/or other relevant authorities and will take all relevant precautionary measures as advised.

# 2. SHAREHOLDERS' PARTICIPATION AT THE 21<sup>ST</sup> AGM VIA REMOTE PARTICIPATION AND VOTING ("RPV") FACILITIES

Shareholders are to attend, speak (including posing questions to the Board via real time submission of typed texts) and vote (collectively, "participate") remotely at the 21<sup>st</sup> AGM using the RPV facilities via <u>https://rebrand.ly/AEM-AGM.</u>

A shareholder who has appointed a proxy or attorney or authorised representative to participate at this 21<sup>st</sup> AGM via RPV facilities must request his/her proxy or attorney or authorised representative to register himself/ herself for RPV at <u>https://rebrand.ly/AEM-AGM</u>.

We **strongly encourage** you to participate in the 21<sup>st</sup> AGM via the RPV facilities. You may also consider appointing the Chairman of the Meeting as your proxy to attend and vote on your behalf at the 21<sup>st</sup> AGM.

Kindly refer to the Procedures for RPV as set out below for the requirements and procedures.

# 3. PROCEDURES FOR RPV

Please read and follow the requirements and procedures below to engage in remote participation through live streaming and online remote voting at the 21<sup>st</sup> AGM using the RPV facilities:-

(b)	Submit your online registration to participate the 21 <sup>st</sup> AGM remotely	<ul> <li>Registration for the 21<sup>st</sup> AGM is open from Friday, 29 July 2022 at 9.00 a.m. and the registration will be closed on Wednesday, 28 September 2022 at 10:00 a.m. Shareholder(s) or proxy(ies) or corporate representative(s) or attorney(s) are required to pre-register their attendance for the 21<sup>st</sup> AGM to ascertain their eligibility to participate the 21<sup>st</sup>AGM using the RPV facilities.</li> <li>Clicking on the link will redirect you to the 21<sup>st</sup> AGM event page. Click on the <b>REGISTER</b> link for the online registration page. Your name <b>MUST</b> match your CDS account name [not applicable to proxy(ies) or corporate representative(s) or attorney(s)].</li> <li>Kindly fill in the CDS account number and indicate the number of shares you hold. If you have more than one CDS account, please state the CDS account number and indicate the number of shares you hold. If you proceed to click <b>SUBMIT</b> to register for your remote participation. Failure to do so will result in your registration for remote participation. Failure to do so will result in your registration for remote participation is received and pending verification.</li> <li>After verification of your registration against the Record of Depositors as at 22 September 2022, the system will send you an e-mail after 23 September 2022 to approve or reject your registration for remote participation.</li> </ul>

First reminder will be sent one day before the 21<sup>st</sup> AGM day, while the second reminder will be sent an hour before the commencement of the 21<sup>st</sup> AGM.</li> <li>Click JOIN EVENT in the reminder email for remote participation at the 21<sup>st</sup> AGM at any time from 9:00 a.m., i.e. an hour before the commencement of the 21<sup>st</sup> AGM on Thursday, 29 September 2022 at 10:00 a.m.</li> <li>Please ensure you have downloaded and installed Cisco Webex Meetings application before attending the Virtual 21<sup>st</sup> AGM.</li> </ul>				
(b)	Participate through Live Streaming	<ul> <li>You will be given a short briefing on the RPV facilities.</li> <li>Your microphone will be muted throughout the whole session.</li> <li>If you have any question for the Chairman/ Board of Directors, you may use the Q&amp;A PANEL to transmit your questions. The Chairman/ Board of Directors will endeavour to respond to relevant questions submitted by remote participants during the 21<sup>st</sup> AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.</li> <li>The meeting session will be recorded.</li> <li>Please note that the quality of the live streaming is dependent on the bandwidth and stability of the internal connection at your location.</li> </ul>				
(c)	Online Remote Voting	<ul> <li>The Chairman of the Meeting will announce the commencement of the voting session and the end of the voting session of the 21<sup>st</sup> AGM.</li> <li>The list of resolutions for voting will appear at the right-hand side of your computer screen. You are required to indicate your votes for the resolutions that are tabled for voting within the given time frame.</li> <li>Confirm and click the <b>SUBMIT</b> button upon completion to submit your votes.</li> <li>The decision of votes cannot be changed once it is submitted.</li> </ul>				
(d)	End of remote participation	• Upon the announcement by the Chairman on the closure of the 21 <sup>st</sup> AGM, the live streaming will end.				

# 4. ENTITLEMENT TO PARTICIPATE AND APPOINTMENT OF PROXY

Only members whose names appear on the Record of Depositors as at 22 September 2022 shall be eligible to participate in the 21<sup>st</sup> AGM or appoint proxy(ies) or corporate representative(s) or attorney(s) and/or the Chairman of the Meeting to participate and vote on his/her behalf.

The hard copy of the proxy forms and/or documents relating to the appointment of proxy(ies) or corporate representative(s) or attorney(s) for the 21<sup>st</sup> AGM shall be deposited by hand or post with the Company's Share Registrar at Workshire Share Registration Sdn. Bhd. of A1-2-2, Solaris Dutamas, No. 1, Jalan Dutamas 1, 50480 Kuala Lumpur, Malaysia not later than **Tuesday, 27 September 2022** at **10:00 a.m.** 

All members are strongly encouraged to participate and vote remotely at the 21<sup>st</sup> AGM using the RPV facilities. The procedures and requisite documents to be submitted by the respective members to facilitate remote participation and voting are summarised below:-

## (I) For Individual Members

If an individual member is unable to participate the 21<sup>st</sup> AGM, he/she is encouraged to appoint proxy(ies) or the Chairman of the meeting as his/her proxy and indicate the voting instructions in the Proxy Form in accordance with the notes and instructions printed therein.

## (II) For Corporate Members

Corporate members [through the appointment of Corporate Representative(s) or proxy(ies)] who wish to participate and vote remotely at the 21<sup>st</sup> AGM must contact the Company's Share Registrar with the details set out below for assistance and is required to deposit the following documents to the Company's Share Registrar no later than **Tuesday, 27 September 2022** at **10:00 a.m.**:

- (a) Certificate of appointment of its Corporate Representative or Proxy Form under the seal of the corporation;
- (b) Copy of the Corporate Representative's or proxy's MyKad (front and back)/Passport; and
- (c) Corporate Representative's or proxy's email address and mobile phone number.

Upon receipt of such documents, the Company's Share Registrar will respond to your remote participation request.

If a corporate member [through the appointment of Corporate Representative(s) or proxy(ies)] is unable to participate the 21<sup>st</sup> AGM, the corporate member is encouraged to appoint the Chairman of the Meeting as its proxy and indicate the voting instructions in the Proxy Form in accordance with the notes and instructions printed therein.

## (III) For Institutional Members

The beneficiaries of the shares under a Nominee Company's CDS account ("Institutional member(s)") who wish to participate and vote remotely at the 21<sup>st</sup> AGM may request its Nominee Company to appoint him/her as a proxy to participate and vote remotely at the 21<sup>st</sup> AGM. The Nominee Company must then contact the Company's Share Registrar with the details set out below for assistance and is required to deposit the following documents to the Company's Share Registrar no later than **Tuesday**, **27 September 2022** at **10:00 a.m.**:

- (a) Proxy Form under the seal of the Nominee Company;
- (b) Copy of the proxy's MyKad (front and back)/Passport; and
- (c) Proxy's email address and mobile phone number.

Upon receipt of such documents, the Company's Share Registrar will respond to your remote participation request.

If an institutional member is unable to participate the 21<sup>st</sup> AGM, the institutional member is encouraged to appoint the Chairman of the Meeting as its proxy and indicate the voting instructions in the Proxy Form in accordance with the notes and instructions printed therein.

# 5. REVOCATION OF PROXY

Please note that if a Shareholder has submitted his/her Proxy Form prior to the 21<sup>st</sup> AGM and subsequently decides to personally participate in the 21<sup>st</sup> AGM via RPV facilities, the Shareholder must contact the Company's Share Registrar to revoke the appointment of his/her proxy no later than **Tuesday**, **27 September 2022** at **10:00 a.m.** 

# 6. VOTING AT MEETING

The voting at the 21<sup>st</sup> AGM will be conducted on a poll in accordance with Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Malaysia"). The Company has appointed Aldpro Corporate Services Sdn. Bhd. as the Poll Administrator to conduct the poll voting electronically and CSC Securities Services Sdn. Bhd. as Independent Scrutineers to verify the poll results.

Shareholders can proceed to vote on the resolutions before the end of the voting session which will be announced by the Chairman of the Meeting and submit your votes at any time from the commencement of the voting session announced by the Chairman of the Meeting. Kindly refer to the "**Procedures for RPV**" provided above for guidance on how to vote remotely via the RPV facilities. The Scrutineers will verify and announce the poll results followed by the Chairman's declaration whether the resolution tabled for voting is duly passed or otherwise.

## 7. RESULTS OF THE VOTING

The resolutions proposed at the 21<sup>st</sup> AGM and the results of the voting for the same will be announced at the 21<sup>st</sup> AGM and subsequently via an announcement made by the Company through Bursa Malaysia at <u>www.bursamalaysia.com</u>.

## 8. NO RECORDING OR PHOTOGRAPHY

By participating at the 21<sup>st</sup> AGM, you agree that no part of the 21<sup>st</sup> AGM proceedings may be recorded, photographed, stored in any retrieval systems, reproduced, transmitted or uploaded in any form, platform or social media or by any means whether it is mechanical, electronical, photocopying, recording or otherwise without the prior written consent of the Company. The Company reserves the rights to take appropriate legal actions against anyone who violates this rule.
